2.This Office has no objection to the construction of the proposed Office building by M/s Bhoruka Park Pvt. (Thirty Nine decimal Zero Five meters only) ABOVE GROUND LEVEL, so that the top of the proposed structure when erected shall not exceed 939.316 Mts. AMSL (ABOVE MEAN SEA LEVEL), i.e 900.266Mts (Site elevation) + 39.05 Mts (Height of the structure).
