This has reference to the Show cause notice issued vide letter at reference no.3 seeking explanation for submission of false documents towards the work experience for the subject tender.

Your reply vide e-mails mentioned under reference (4) to the show cause notice is not satisfactory and you have uploaded false completion certificate on e-portal towards qualifying work which was carried out for your client M/s ISRO(VSSC).

It is understood that, you were not having relevant documents towards qualifying work and false documents towards the work experience uploaded on e-portal for the subject tender.

Hence, above act of submitting false documents falls under unlawful fraudulent practice carried out by a firm during tendering process. Accordingly, Management has taken the decision to debar M/s N R Engineering Services, from participating in HAL tenders for a period of Two years effective from 04.10.2023

Therefore, on behalf of the accepting officer of HAL, acting under the powers vested on me and vide Clause-35 "Instruction to tenderer" of the contract and without prejudice to any other right or remedy which shall have accrued or shall accrue here after to HAL, under the same terms of the above said tender clause, I hereby inform you that your company M/s N R Engineering Services is debarred from quoting for HAL works for a period of 02 (Two) year effective from 04.10.2023
